

Privacy Policy For Intelliga Corporation

Introduction

Intelliga Corp DBA Bland AI ("we," "us," "our," or "Bland AI") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our artificial intelligence phone calling system and related services (collectively, the "Service"). - **With Affiliates and Business Partners:** We may share your information with our affiliates and business partners for the purposes described in this Privacy Policy.
